**ORDER ON DEFENDANT'S "MOTION REQUESTING ORDER FINDING
ADMINISTRATIVE ORDER 2011-059, §(I)(4) PA/PI-CIR DOES NOT APPLY TO
PARTIES SEEKING A WRIT FROM A DISTRICT COURT OF APPEAL"**


THIS CAUSE came before the Court on Defendant's "Motion Requesting Order Finding Administrative Order 2011-059, §(I)(4) PA/PI-CIR Does Not Apply to Parties Seeking a Writ from a District Court of Appeal." Having reviewed the motion, record, and applicable law, the Court finds as follows:

Defendant's motion requests that the Court issue an order finding that section (I)(4) of Administrative Order 2011-059 does not apply to Defendant or for a waiver of the requirement in that section. The Court will grant Defendant's alternative request to waive the requirement in this instance. Defendant has represented that he will supply a copy of the transcript to the State and to the Second District Court of Appeal. The transcript of the hearing on Defendant's motion for immunity need not be filed with the Clerk of Court in the Sixth Circuit, and Defendant need not pay for copies of the transcript other than the original.

Accordingly it is,

ORDERED AND ADJUDGED that Defendant may purchase a transcript of the motion for immunity hearing without paying for a copy, and the Administrative Office of the Courts is not required to file that transcript with the Clerk.

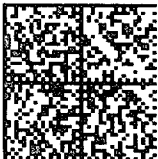
