**Stipulation Of Facts
Regarding State Exhibits #2, and #3**


In 2014, Cobb Grove 16, 6333 Wesley Grove Blvd, Wesley Chapel, Pasco County, FL 33544 was operating as a multiplex movie theater offering a CineBistro experience in several of the theaters. Surveillance cameras controlled by a proprietary DVR system was installed in the theaters offering the CineBistro experience, which included Theater #10. Along with the cameras in the theaters, cameras were installed at the ticket window, the lobby, the concession area and the customer service area.

State's Exhibit #2, and #3 are exhibits from previously stipulated video evidence which captured some of the interaction of Chad Oulson and Curtis Reeves inside The Cobb Grove 16 Theater at various locations, including Theater #10 on January 13, 2014.


Further, the State and Defense stipulate and agree the blue screens seen in State's Exhibits #2 represents the time where the motion activated camera system did not record any video.

Further, the State and the Defense stipulate and agree the embedded timestamp seen on the video runs continually from the beginning to the end of the video. This timestamp includes the time the system did not record video as represented by the blue screens.


