**STIPULATED ORDER AMENDING ORDER ON DEFENDANT'S MOTION TO
COMPEL DISCLOSURE**

THIS CAUSE came on to be heard on June 10, 2015 upon the Defendant's Motion to Compel Disclosure, requesting among other things, the right of the Defense and its expert(s) ("the Defense") to inspect, copy, photograph, and test Chad Oulson's cellular phone ("cellular phone") seized on January 13, 2014 (Type: iPhone 5 (GSM); Model No. MD635; Serial No. DNPk2UU5DTTP), and the Court being fully advised in the premises, signed an Order on Defendant's Motion to Compel Disclosure on July 13, 2015;

Based on newly discovered evidence, the State and the Defense stipulate that the existing July 13, 2015 Order on Defendant's Motion to Compel Disclosure be amended.

Accordingly, the State and the Defense hereby stipulate to the following Stipulated Order Amending Order on Defendant's Motion to Compel Disclosure.

IT IS HEREBY ORDERED that the Defense may inspect, copy, photograph, and test the cellular phone subject to the following terms and conditions:

- (i) The Defense expert Dr. Michael Antal may copy any and all data contained on the cellular phone onto another hard drive ("imaged hard drive");
- (ii) Dr. Antal's copying of this data from the cellular phone to the imaged hard drive shall be performed at a Pinellas County Sheriff's Office facility mutually agreeable to the State and the Defense;
- (iii) Dr. Antal and the State's expert shall meet at a mutually agreed upon date and time to image the cellular phone data;

- (iv) the State shall ensure that the cellular phone can be activated (i.e. turned on) at the time the Dr. Antal and the State's expert visit the Pasco County Sheriff's Office facility to image the cellular phone data;
- (v) the State shall also ensure that the cell phone is fully charged and any password protection feature(s) on the cellular phone can be bypassed at the time the Dr. Antal and the State's expert visit the Pinellas County Sheriff's Office to image the cellular phone data;
- (vi) Dr. Antal shall maintain possession, care, and control of the imaged hard drive;
- (vii) Dr. Antal shall be permitted to transport the imaged hard drive to his office, provided that he maintains possession, care, and control of the target hard drive at all times;
- (viii) Dr. Antal will be allowed access to *all data* on the phone, including but not limited to the previously uninterpreted data and file/system metadata;
- (ix) Dr. Antal shall not disclose any data from on or before January 12, 2014 to any attorney or employee of Escobar & Associates, P.A.; Dr. Antal shall take the necessary and available technical and physical precautions to ensure full compliance with this condition;
- (x) Dr. Antal shall not disseminate the contents of the imaged hard drive beyond that which is permitted by the court;
- (xi) Dr. Antal shall comply with any terms and conditions imposed by the Court regarding the cellular phone data and the imaged hard drive.

At any future hearing or trial, the State does not waive its right to object to the admission of any evidence obtained from the cellular phone.
