ORDER ON DEFENDANT'S MOTION TO
COMPEL DISCLOSURE

THIS CAUSE came on to be heard on JUNE 10, 2015 upon DEFENDANT'S MOTION TO COMPEL DISCLOSURE, requesting among other things, the right of the Defense and its expert(s) ("the Defense") to inspect, copy, photograph, and test (i) the Defendant's left and right shoes worn on January 13, 2014, (ii) the Defendant's firearm used on January 13, 2014, (iii) the Defendant's ammunition seized on January 13, 2014, (iv) Chad Oulson's cellular phone ("cellular phone") seized on January 13, 2014, and (v) the digital video recorder hard drive(s) for the movie theater surveillance system, and the Court being fully advised in the premises:

The Court having previously decided all issues pertaining to the Defendant's Motion to Compel except for those pertaining to the cellular phone;

The Estate of Chad Oulson having requested an order restricting discovery as it pertains to the data contained on the cellular phone Chad Oulson was using in the Cobb Grove Theater on January 13, 2014 (Type: iPhone 5 (GSM); Model No. MD635; Serial No. DNPk2UU5DTTP),

IT IS HEREBY ORDERED AND ADJUDGED that DEFENDANT'S MOTION TO COMPEL DISCLOSURE is GRANTED IN PART, and the defense may inspect, copy, photograph, and test the cellular phone subject to the following terms and conditions:

- (i) the Defense may copy any and all data contained on the cellular phone onto another hard drive ("mirrored hard drive");
- (ii) the Defense's copying of this data shall be performed at a Pasco County Sheriff's Office facility;
- (iii) the Defense may copy any and all cellular phone data transmitted and/or received on

- January 13, 2014 from the mirrored hard drive to a separate storage device;
- (iv) the Defense shall have possession, care, and control of the separate storage device containing the January 13, 2014 cellular phone data;
 - (v) the Defense shall not disseminate the contents of the separate storage device containing the January 13, 2014 cellular phone data to any third-parties;
 - (vi) the mirrored hard drive shall be given to the State, which shall maintain care and control of the mirrored hard drive; and
 - (vii) the State shall not alter, manipulate, or access the data on the mirrored hard drive.
