**ORDER ON DEFENDANT'S MOTION TO
COMPEL DISCLOSURE**

THIS CAUSE came on to be heard on MAY 29, 2015 upon DEFENDANT'S MOTION TO COMPEL DISCLOSURE, requesting among other things, the right of the Defense and its expert(s) ("the Defense") to inspect, copy, photograph, and test (i) the Defendant's left and right shoes worn on January 13, 2014, (ii) the Defendant's firearm used on January 13, 2014, (iii) the Defendant's ammunition seized on January 13, 2014, (iv) Chad Oulson's cellular phone seized on January 13, 2014, and (v) the digital video recorder hard drive(s) for the movie theater surveillance system, and the Court being fully advised in the premises:

The Court having ruled that it will reserve decision on the Defendant's request regarding Chad Oulson's cellular phone until June 10, 2015,

And the Defense having withdrawn its request for permission to inspect, copy, photograph and test the Defendant's ammunition,

IT IS HEREBY ORDERED AND ADJUDGED that DEFENDANT'S MOTION TO COMPEL DISCLOSURE is GRANTED IN PART, and the defense may inspect, copy, photograph, and test:

- (i) the Defendant's left shoe he wore on January 13, 2014; the Defense may take possession, care, and control of the left shoe for the purposes of inspection, photographing, and testing; the Defense shall have possession, care, and control of the left shoe for up to an uninterrupted five-day period starting on a Monday and ending on a Friday; the Defense shall comply with the procedures of the agency in possession of the above-referenced item regarding the removal, transfer, and preservation of

evidence;

- (ii) the Defendant's firearm, provided that any inspection, photographing and testing by the Defense shall occur at a Florida Department of Law Enforcement facility or a Pasco County Sheriff's Office facility; and
- (iii) the digital video recorder hard drive(s) of the movie theater surveillance system; the Defense shall have the right to copy all of the contents of said hard drives onto separate storage devices; the Defense shall have uninterrupted access to the digital video recorder hard drive(s) at the government facility where the hard drive(s) are being stored; in the event the Defense requires overnight or extended copying or testing at the government's facility, then the relevant hard drive(s) shall be stored in a secure room during any overnight period; the Defense may assume possession, care, and control of the separate storage devices.
