**ORDER FOR PRE-TRIAL CONFERENCE APRIL 30<sup>th</sup> 2015**

By this Order the Court sets a Pre-trial on April 30<sup>th</sup> 2015 at 4:00pm as previously announced in court at Pre-trial January 29<sup>th</sup> 2015. **This pretrial will be held at the West Pasco Judicial Center in New Port Richey, COURTROOM 2A.** During the Pre-trial on April 30<sup>th</sup> 2015 the following will be expected of the State and Defense:

1. The Defendant will be present for the Pre-trial.
2. The State will have an accounting of all outstanding discovery still to be disclosed by the State to the Defense and a proposed time line for completion.
3. The Defense will have an accounting of all outstanding reciprocal discovery still to be disclosed by the Defense to the State and a proposed time line for completion. This will include medical records, expert witnesses and reports from experts.
4. The Court will want an accounting of the number of depositions completed on April 30<sup>th</sup> 2015 and the number of depositions still remaining. The Court will want an accounting of the dates that depositions are set and if any depositions that need to be taken are not yet set on a specific date.

5. The Court announced on January 29<sup>th</sup> 2015 that there will be a additional pre-trial held May 28<sup>th</sup> at 4:00pm to finalize discovery and set motions.
6. The Court announced on January 29<sup>th</sup> 2015 that there will be 3 days blocked off for testimony and argument on August 3<sup>rd</sup> through August 5<sup>th</sup> 2015 if an immunity motion is filed. This will be held in the Dade City Courthouse.
7. The current trial date is August 24<sup>th</sup> 2015 at the Dade City Courthouse. The estimated time for trial is through September 11<sup>th</sup> 2015.
8. If either side is planning to call witnesses during the trial, they are to verify days of non-availability August 30<sup>th</sup> 2015 thru September 9<sup>th</sup> 2015.
