BERNIE McCABE, State Attorney for the Sixth Judicial Circuit of Florida, in and for Pasco County, prosecuting for the State of Florida, in the said County, under oath, Information makes that

CURTIS JUDSON REEVES

in the County of Pasco and State of Florida, on the 13th day of January, in the year of our Lord, two thousand fourteen, unlawfully, by an act imminently dangerous to another, and evincing a depraved mind regardless of human life, but without a premeditated design to effect the death of any particular individual, did kill Chad Oulson, by shooting Chad Oulson with a firearm, and during the commission of the offense, CURTIS JUDSON REEVES actually possessed and discharged a firearm and, as the result of the discharge, death or great bodily harm was inflicted upon Chad Oulson; contrary to Chapter 782.04(2)/775.087(2)(a)3, Florida Statutes, and against the peace and dignity of the State of Florida. And the State Attorney aforesaid, under oath as aforesaid, further information makes that CURTIS JUDSON REEVES, in the County of Pasco, State of Florida, on the 13th day of January, in the year of our Lord, two thousand fourteen, did actually and intentionally touch or strike Nicole Oulson with a deadly weapon, to-wit: firearm, against the will of Nicole Oulson, and during the commission of the offense, CURTIS JUDSON REEVES discharged a firearm; contrary to Chapter 784.045(1)(a)2/775.087(2)(a)2, Florida Statutes, and against the peace and dignity of the State of Florida.
